FIXTURES AND EQUIPMENT



Free Devices

Multifamily residential properties over 10 dwelling units are eligible for free water-saving devices as part of the free Water-Wise Evaluation. Properties with less than 10 dwelling units may receive them during the evaluation or pick them up from SFPUC's Customer Service Center. Customers may schedule a visit by calling 415-551-4730. The following items are free while supplies last: kitchen and bathroom faucet aerators, water-efficient showerheads, toilet flappers, toilet fill valve, flow measurement bags, toilet tank dye tablets, pre-rinse spray valves, and garden spray nozzles. Note that toilet fill valves and pre-rinse spray valves are not available over the counter and only available through a Water-Wise Evaluation.

Plumbing Fixture Replacement Program (PREP)

PREP targets the entire building by replacing old toilets and urinals with water-efficient models for residential account holders. Properties must have existing toilets that use at least 3.5 gallons per flush and/or urinals that use more than 1.0 gallons per flush. Residential properties purchased after July 1, 2009 are not eligible.

High-Efficiency Clothes Washer Rebate

Multifamily properties can participate in the coin operated (commercial) washer or residential clothes washer rebate programs depending on the type of new washer installed. The commercial program offers up to \$500 per machine when commercial grade common area clothes washers are replaced with a high-efficiency model with a water factor of 4.5 or below. The residential program offers up to \$100 for a 2018-2019 Energy Star Most Efficient high-efficiency washer.

Rainwater Harvesting Program

Customers can receive rebates on pre-approved equipment: \$100 discount on a 50-gallon rain barrel or \$350 discount on a cistern that is up to 700 gallons.

TECHNICAL ASSISTANCE



Water-Wise Evaluation

Multifamily property owners and managers can receive a free evaluation to identify costly leaks and inefficient equipment. SFPUC's water efficiency technicians provide the following services during an evaluation:

- Review a property's water use and discuss reduction goals.
- Check indoor plumbing fixtures and water-using appliances for leaks and water efficiency.
- Provide and in some cases install free devices and materials.
- Inspect irrigated landscaping and provide tips for efficient outdoor water use.
- Provide information on water-saving rebates and incentives.
- Provide a customized report of the findings.

Monitor Water Use

The SFPUC advises water-service account holders to register for MyAccount, an online platform for viewing water use and billing history. Regularly checking daily and hourly water use can help property managers understand what is typical for their building and what may be unusual and reflect potential leaks or other problems. The SFPUC also automatically issues courtesy alerts to multifamily properties with two to five dwelling units after three days of constant water use over 7.5 gallons an hour, and provides potential one-time bill adjustments for properties that demonstrate prompt leak repair.
